- Held a Professionalism Roundtable Luncheon, which provided mentoring to young lawyers practicing in Manatee County by seasoned practitioners and members of the judiciary (led by YLD Board Members Amanda Tullidge and Bryony Swift)
- Expanded the Art Creations in the Courthouse exhibit on the 5th Floor of the Manatee County Judicial Center and hosted a reception for the students and their art teachers and families which was attended by several members of the MCBA and the judiciary (led by YLD Board Members Bryony Swift and Annie Breitinger)
- Participated in Career Day by speaking to students at Braden River Middle School about the practice of law (YLD Board Members Sean Flynn and Jesse Tilden)

But if I'm being completely honest, we also encountered a humbling experience. In December, our YLD Board of Directors attempted to build a Gingerbread House to participate in the Community Youth Development's Gingerbread Festival. MESSAGE from the COURT ADMINISTRATOR MCJC ATTORNEY BUSINESS CENTER

As a reminder to all members, the Attorney Business Center located on the 6th Floor of the judicial center is only to be used by lawyers who are doing business in the judicial center. There are PC's with internet access and MS Word, a fax machine and a scanner. If you are in court and need something last minute, this is your place to go. However, this room is not to be used to meet with your clients, and it is not to be used by legal assistants, paralegals or investigators – it is for licensed attorneys only.

In 2012, at the request of local criminal defense attorneys, the Manatee County Sheriff's Office installed a telephone in the Attorney Business Center which has direct-dial access to the jail pods. This phone is only to be used by attorneys to call clients housed at the jail. Attorneys are reminded that their staff, friends and/or family members of defendants are not permitted to use this phone and are not permitted to be in the Attorney Business Center. It has been noticed by MSO at the jail that non-lawyers have been calling into the jail pods from this line, and we have been asked to protect the integrity of this direct connection or we will lose it. Instructions for using this telephone are available in the Attorney Business Center.

As a result of numerous non-lawyers found using the Attorney Business Center we have changed the combination of the door lock. Before giving out the combination to requestors, it is our policy to verify that the requestor is a member of The Florida Bar. Attorneys may contact The Manatee County Bar office (741.4091) or Court Administration (749.3655) for the new code.

2016 marks the 53rd anniversary of the landmark U.S. Supreme Court Gideon v. Wainwright decision. In recognition, the MCBA will be most honored to host Bruce R. Jacob as keynote speaker for our September meeting. Mr. Jacob is Dean Emeritus and Professor of Law at Stetson University College of Law. In the early 1960's, he was the Assistant Attorney General of Florida who represented the State before the U.S. Supreme Court in the Gideon v. Wainwright case. It was Mr. Jacob who argued that Clarence Gideon, an indigent, poorly educated man charged with a felony, had no right to be provided with counsel by the State of Florida. Although he lost the case, the Court held that it was consistent with the Constitution to require state courts to appoint attorneys for defendants who could not afford to retain counsel on their own.

Manatee Bar members should make plans to attend and hear his personal historical perspective of this legendary case.



The 2016 7th grade Civics Education Project was a big success - all of the feedback from teachers and students was very positive - too many e-mails and thank you notes were received to acknowledge everyone. In 2014, our first year of the program, we reached 6 schools, 38 classrooms and 900 7th graders. Last year, in 2015, we reached 7 schools and although I don't have definitive numbers, the program was definitely taking hold.

This year we reached every middle school in the Manatee County School District (10); 112 of the 113 possible class periods available; with an av-

erage of 25-30 students in each class period, the total number of Manatee County 7th grade students reached was between 2,800 and roughly 3,500. WOW.
