Reduce criminal recidivism.

Facilitate participant mental wellness and sobriety.

Increase compliance with treatment and other court ordered conditions.

Improve access to VA benefits and services.

Improve quality of life and stability.

Maintain Public Safety



## In Memorium:

**Judge W. Clayton Johnson**

**September 25, 1924 - November 17th, 2017**



Judge Johnson was born and raised in Duluth, Minnesota, and served during WWII in the European Theater, where he was a flight engineer/gunner on a B26 bomber. Upon returning home after WWII, he met and married his wife, Vada Colleen Salo, on December 21st, 1948. He attended the University of Miami where he was a collegiate Golden Gloves boxing champion while earning a degree

in Accounting. Upon graduating, he then attended the FBI training academy at Quantico and served as a field agent from 1951 to 1958 where he earned a Law Degree from New York University. His career included being a prosecutor, public defender, and a private practice attorney until accepting an appointment to the

Judicial Bench in Broward County, Florida, where he served as a distinguished judge for the next 28 years until his retirement in 1996. Upon retirement, he relocated to Palmetto, Florida and continued to serve as a Senior Judge when called upon until 2003. Judge Johnson is survived by his wife of 68 years, Vada C. (Salo): daughter, Laura Good (John) of Deerfield Beach, Florida; son, Clayton D. (Kim) of Palmetto, Florida; grandsons, Tyler Good and Kyle Good, of Pompano Beach, Florida and granddaughters, Kaitlyn Johnson and Kristen Johnson of Palmetto, Florida. ## 12th Circuit Participates In Community Diversity Event Held At New College Of Florida

On November 16th, 2017, the Boxser Diversity Initiative presented “The Freedom Riders; Their Relevancy Today” on the campus of New College of Florida. This panel discussion was preceded by a performance of the Booker High School “Jet Stream” vocal group and a short film tribute produced by Manatee Educational Television.

The panel featured Dr. Ray Arsenault who was the author of Freedom Riders: 1961 and the Struggle for Racial Justice which was the basis of the award winning PBS program of the same name. The

panel also included Ellen Ziskind, an original freedom rider who was imprisoned in the infamous Parchman Prison in Mississippi for her activity as a freedom rider. The final panel member was Dr. Michael Jeffries, author, lecturer and Professor of American Studies at Wellesley College. The panel was moderated by Judge Charles E. Williams, Chief Judge of the 12th Judicial Circuit. The sold out event celebrated the legacy of the 1961 Freedom Riders and contrasted that movement with the modern movements for social justice and racial equality

## January General Membership Meeting — Welcome, Congressman Dan Miller!

This month, the MCBA is honored to have Congressman Dan Miller, Member of Congress, Florida, 1993-2003 as our guest speaker. During his ten years in the House, Dan served on the House Appropriations Committee and the Budget Committee. He served as Chairman of the Census subcommittee with oversight of the U.S. Census Bureau during the controversial and successful 2000 census. As a staunch fiscal conservative, Dan was committed to both reducing the size and scope of the federal government and fighting corporate welfare. During his time in Congress the Federal budget had a surplus for four years and we paid down the country's debt. On 9/11 Dan was with President Bush at Booker Elementary School in Sarasota and flew with him on Air Force One.

After leaving Congress, Dan returned to academia. In 2003 Dan was a Fellow at the Institute of Politics at the Kennedy School of Government at Harvard University. He taught in the Lifelong Learning program at the University of South Florida and also teaches at university campuses in the "Congress to Campus" program working to bridge the gap between academia and the real world of politics and public service. He has taught at over twenty universities including the Naval Academy, University of Toronto, University of Massachusetts, University of Guadalajara, University of Kansas and Oxford University in England.

# WELCOME TO OUR NEWEST MANATEE COUNTY JUDGE, THE HONORABLE RENÉE INMAN

We welcome the Honorable Renée Inman as our newest Manatee County Court Judge. Judge Inman began hearing County Court cases on December 11, 2017. When Governor Rick Scott appointed Judge Inman on November 27, 2017, she made history as the first woman appointed to this position in Manatee County. She also became the second woman to serve in this position following

Judge Roberta Knowles, who was first elected in 1977 and served through 1982.

Judge Inman has traveled a long way to become the next Manatee County Judge. As a daughter of a U.S. Army soldier, she grew up in many locations throughout the United States and Germany. Judge Inman's family immigrated from France to New Brunswick, Canada in the 1720's. Her father immigrated to the United States from Canada as a teenager before joining the Army and becoming a U.S. citizen at the age of 23.

In her time as an "army brat", Judge Inman attended many different schools, including 3 high schools. After graduating from Lowell Catholic High School in Lowell, Massachusetts, she received her B.A. in history from Indiana University in 1997 before pursuing a law degree at Western New England College School of Law. In law school, Judge Inman met her husband Peter, a fourth generation Floridian from Lakeland. After graduating with her J. D. in 2000,

she clerked for the trial courts in Massachusetts and Maine, and then began practicing with the Bangor law firm of Gross, Minsky & Mogul, P.A., specializing in medical malpractice defense.


In 2005, after several winters in Maine and with family in Florida, Judge Inman and her husband relocated here, where she accepted a position as Court Counsel of the 12th Judicial Circuit. On October 11, 2010, Chief Judge Lee Haworth appointed her as General Magistrate, where she has presided over a variety of family, probate and dependency cases. Her duties as a General Magistrate prepared her for her next important position as a County Judge serving Manatee County.

Since her move to Manatee County, Judge Inman has been involved in the community. In addition to being an active member of the Manatee County Bar Association where she enjoys participating in the annual Law Day programs, she currently serves as a vice president to the Manatee Inns of Court and participates in her daughters' activities. Judge Inman is also a concert level violinist, who learned to play at the young age of six years old. She stays busy performing with the Venice Symphony and Anna Maria Island Concert Chorus and Orchestra. She and Peter enjoy living in Manatee County and raising their two daughters, ages 11 and 8.



## YLD News & Happenings 2018: Could this *finally* be the End?

I am referring to an end of Florida’s no-fault auto insurance system, of course. Personal-Injury Protection (PIP) is back on the chopping block in 2018. Advocates of repealing Florida’s no-fault system have kept their foot on the gas since the 2017 legislative session - citing \$1 Billion in driver savings as a catalyst for change. Consequently, the House and Senate will start this year off reviewing proposals for combating

Florida’s rising auto insurance premiums and fraudulent claims.

First, Rep. Erin Grall, R-Vero Beach, has proposed The Responsible Roadways Act, HB-19, to end the no-fault system, which requires motorists to carry PIP coverage to help pay for medical care after accidents. Under Florida’s no-fault system, motorists are not required to have bodily injury coverage but must carry \$10,000 in PIP coverage, an amount that essentially hasn’t changed in decades. The system was designed to help limit lawsuits stemming from traffic accidents. Proponents for change argue the system has back-fired, and despite efforts to curtail PIP fraud (reformed in 2012), PIP premiums are up an average of 25 percent since the start of 2015.

Florida is one of two states that does not require bodily injury liability coverage. Backers of the House bill believe it provides a common-sense solution for holding at-fault drivers accountable to liability for damages with the hope of shifting costs to health care premiums. Grall’s bill is set for the House floor in January 2018. A key provision of HB-19 would end the PIP requirement and instead require motorists to carry \$25,000 in bodily-injury coverage per person and \$50,000 per accident. Plus, in attempt to preserve driver savings with these proposed changes, HB-19 does not mandate medical payments coverage. Grall sees mandatory medical coverage as an unfair cost to drivers that pay premiums already for health insurance. However, the lack of mandatory medical coverage has some interest groups opposed to the bill out of fear that medical providers will not be paid timely or adequately for their services.

On the other hand, in the Senate, Thonotosassa Republican Tom Lee has also proposed a bill to repeal PIP. Lee is sponsoring SB-150 which is set to appear before the Senate Banking and Insurance Committee on January 9th. SB-150 differs from HB-19 with the levels of required bodily injury coverage. Under SB-150, coverage would start at \$20,000/ \$40,000 for bodily injury protection as of January 1, 2019, and then increase to \$25,000/ \$50,000 two years later. By January 1, 2023, coverage requirement would increase to \$30,000/ \$60,000 in bodily injury protection.

Senator Lee’s bill also continues mandatory coverage for medical and funeral benefits. That medical coverage distinction between the House and Senate bills could be a real point of contention. In an interview with News Service of Florida back in December of 2017, Senate President Joe Negron, R-Stuart, said:

“It’s important to ensure that any replacement coverage still provides Florida drivers access to medical coverage and funeral benefits. I think med pay is an important component that we need to retain in the system. It makes sure that an emergency room is compensated when someone appears for care after a motor vehicle accident. It’s important to maintain a burial benefit. I think if a terrible, unspeakable tragedy of someone getting killed in an automobile accident, and the family is having to adjust with that permanent alteration of their reality, to have a modest payment to make sure they can afford a funeral and a burial is not too much to ask. I will not support jettisoning that.”

Regardless of what happens with this next round of potential PIP Armageddon, the conversation has been heating up for years and does not appear to be cooling off. Repeal efforts gained traction with the House passing Grall’s last proposed bill during the 2017 legislative session before it died in the Senate Appropriations Subcommittee on Health and Human Services. So, considering the momentum behind repeal efforts, will we finally bear witness to the end of Florida’s no-fault era in 2018?




