A Partner for the Ages

Thomas Patrick Flynn, my partner of almost 30 years, died unexpectedly on February 18th.

I was thinking that if Tom was preparing this article about me, he would agonize over its content and spend hours writing draft after draft. Why? Because Tom would have wanted his words to be "just right". And that is how Tom had lived his life. He wanted everything to be "just right" for his family, his friends, his clients, his church, his many charitable organizations and just about everything he touched in life.

Tom and I met in law school in Ohio, and we both practiced law in different firms in Dayton, Ohio, for about 10 years. One cold and dark day in November, we met for lunch and talk led to giving serious consideration to relocating to the State of Florida. Tom's mother and father, as well as my mother and father, lived in Florida at the time. We approached our respective families, and at first, both were hesitant and dumfounded, but later grew to the idea.

Tom and I eventually signed a letter of intent to purchase a law firm in Naples, but the deal fell through. Despite this setback, we made the move to Bradenton. In February, 1989, we moved to Manatee County and opened our law firm and began our almost 30 year journey.

In the beginning, we had few clients, and Tom and I would



attend all court proceedings together and meet with all clients together. This dual representation lasted for several years, until business picked up.

A business marriage is just like any other marriage, in which the partners have their ups and downs. Although Tom and I disagreed on some issues, we agreed more often than not, and persevered through our disagreements. We both liked to joke that our partnership lasted longer than many marital relationships.

Ed Murphy and Alyson Battaglia, whom had been with us for several years, eventually joined us as partners, and the journey continued.

Throughout the years, we have been fortunate to have an excellent support staff. Laurie has been with us since the beginning; Sue has been with us 25 years; Kelly has been with us 20 years; and Chris recently celebrated her 10th anniversary. Tom was instrumental in generating this type of loyalty from our wonderful employees, and Tom did everything he could to make sure everything at the office was "just right".

Just days before Tom died, we had discussed how truly blessed we have been to choose Bradenton as our home, and our time together practicing law had been "quite a ride".

I will miss my partner and best friend, as I continue my journey, but I will always keep in mind what Tom taught me: Try to do everything you can to make everything "just right".

THE FLORIDA BAR BOARD OF GOVERNORS SEEKS APPLICANTS FOR APPOINTMENTS TO BE FILLED IN MAY

The Florida Bar Board of Governors makes several special appointments each year. The Board is currently seeking applicants for the following vacancies to be filled during its May 20, 2018, meeting.

American Bar Association House of Delegates: Two lawyers (one under-36 delegate) to serve two-year terms commencing August 2018, at the conclusion of the ABA Annual Meeting. Applicants must also be ABA members.

Florida Legal Services, Inc. Board of Directors: Five lawyers to serve two-year terms commencing July 1, 2018. This is a 21-member board that provides judicial advocacy through co-counseling with local program attorneys and volunteer pro bono attorneys and provides legislative and administrative advocacy on policies impacting the legal rights of the poor, as well as providing civil legal assistance to indigent persons who would not otherwise have the means to obtain a lawyer.

Florida Lawyers Assistance, Inc. Board of Directors: Five lawyers to serve three-year terms commencing July 1, 2018. This 15-member Board assists the legal community in securing counseling and treatment for emotional and chemical dependency problems for lawyers.

Florida Medical Malpractice Joint Underwriting Association Board of Governors: One lawyer to serve a two-year term commencing July 1, 2018. This is a nine-member board of governors that develops a means of obtaining loss and expense experience in medical malpractice issues.

Completed applications must be received by the Executive Director, The Florida Bar, 651 East Jefferson Street, Tallahassee, Florida, 32399-2300 **no later than the close of business on Monday, April 9, 2018**. Resumes will not be accepted in lieu of the required application. The Board of Governors will review all applications and may request telephone or personal interviews.
