## Clerk Of The Court Liaison Committee Begins

The MCBA Board of Directors formed a new Clerk of the Court liaison committee recently. Andre Perron, Faith Brown, and I will lead this committee for the 2021-2022 term. We will monitor changes to our Florida laws or rules that impact our Clerk's office and legal community. More importantly we

want to expedite communications and updates between our Clerk's office and MCBA members monthly.

As you know, our Clerk's office has been hit hard by the pandemic. The current Clerk of the Court, Angelina "Angel" Colonesso, has been fighting to course-correct issues that were created in the wake of Covid-19. Initially, our Clerk's office had to navigate around restrictions that limited employees/services from the start of the pandemic. Thereafter, the Clerk's Office was confronted with a significant decline in revenues, which contributed to employment shortages, and inevitably created delays in filings. However, we believe filing delays are only temporary, and the Clerk has been working overtime to get caught up.

As the Clerk's office continues to proceed through this difficult time, they are still dealing with a shrinking pool of employee candidates. The Clerk adjusted the hourly pay from \$12.95 to \$15.00 dollars, which helped to attract more candidates. Yet, some of the new hires, such as a deputy clerk, can take up to a year to train and earn signature authority. Thus, if you know of hard-working individuals, including highly motivated high school individuals, looking for an opportunity to try a different career path, let them know they should consider applying to the Clerk's office.

Tackling other issues (like funding) may require all-hands-on-deck from the community to maximize impact. MCBA members are encouraged to contact local legislators to press for more funding towards our Clerk's Office. Once matters have returned to normal and funding is adequate, the Clerk intends on implementing changes to the training process. The Clerk would like to obtain modern training modules that educate and test employees faster.

Next, do not forget about the change that occurred with Fla. R. Jud. Admin 2.420 effective July 1, 2021. Currently, the Clerk's office is no longer required to designate and maintain information as confidential unless the filer follows the notice procedures. Thus, filers are solely responsible for ensuring any confidential information contained in court records filed with the Clerk is appropriately/precisely identified for redaction. This means that filers will need to 1) file a notice of confidential information 2) identify the precise location(s) of confidential information, and 3) identify the type of confidential information or provision that is applicable. These changes apply to small claims cases, county court civil cases, and most circuit court civil cases. So, if you are filing documents with Social Security numbers, bank account numbers, or other non-public information, you need to be aware of these changes.
